## 1. Introduction of Purchaser:

Federal Shariat Court of Pakistan established by virtue of the President's Order No.1 of 1980 Constitution (Amdt.) Order, 1980 as incorporated in Chapter 3-A of the Constitution of Pakistan, 1973 (hereinafter called "**Purchaser**").

## 2. Invitation to Bids

- I. The purchaser invites bids, online through EPADS (e-Pak Acquisition and Disposal System) of Public Procurement Regulatory Authority, Islamabad, from the original manufactures/ authorized distributors, resellers, suppliers and General Order Suppliers etc for supply of following items for the official use of this Court.

- III. For the purpose of this tender, Public Procurement Rules 2004 (hereinafter called as "PPRA Rules") shall be strictly followed.

### 3. Instructions to bidders

- i. The bids will only be accepted online through EPADS (e-Pak Acquisition and Disposal System) of Public Procurement Regulatory Authority, Islamabad. No hard copy will be accepted.
- ii. As per Rule 36(b) of PPRA Rules , Single stage - two Envelope bidding Procedure will be adopted for tender/bidding process.
- iii. **Technical bids** will be opened publically on EPADS in the Federal Shariat Court of Pakistan, Constitution Avenue G-5/2, Islamabad by the Procurement Evaluation Committee on **03.03.2025** at 11:30 A.M in presence of Bidder(s) or their authorized representatives(if they opt to participate).
- iv. Only Technically qualified bidders shall be informed through EPADS and telephonically for opening of the Financial Proposal(s). The Financial Proposals will be opened online through EPADS in Federal Shariat Court of Pakistan, Constitution Avenue G-5/2, Islamabad in presence of the Bidders or their authorized representatives (if they opt to participate).
- v. The bids complete in all respect addressed to the Registrar, Federal Shariat Court shall be submitted through EPADS on dates mentioned in the Advertisement.
- vi. All the interested bidders must check the approved samples of Tender items (especially Furniture & Fixture Items) in the Store Branch of Federal Shariat Court of Pakistan, Constitution Avenue, G-5/2, Islamabad. Purchaser will accept the items only if found as per approved Samples.
- vii. **The items specified in the Bid Document may be delivered within 15 days of receiving the supply/work order. However, for items such as computers, printers, and photocopiers, the delivery period may be 6 to 8 weeks, as these items may require to be imported from the manufacturers.**
- viii. In case of any defect appears in Tender items, the same shall be fulfilled by the contractor, through replacement, in a short span of time.
- ix. The requisite items shall be delivered at the purchaser's Principal seat at Islamabad i.e. Federal Shariat Court of Pakistan, Constitution Avenue, G-5/2, Islamabad.
- x. Rate for each item shall be quoted as per samples approved by the Competent Authority and shall be in Pak Rupees only.
- xi. The Purchaser shall announce details of the participated bidders at the time of opening of Technical/ Financial bids through EPADS.
- xii. No bid shall be accepted, unless complete in all respect. Further, conditional bids shall not be accepted/ considered.
- xiii. The bidder (s) shall submit the list of their Partners/ co-owners/ Directors/ Joint

Ventures/ Suppliers along with the bid, if any.

- xiv. The bidder(s) shall bear all costs/expenses associated with the preparation and submission of the bids and the Purchaser shall in no case be responsible for those expenses.
- xv. A bid withdrawn after the deadline for submission of the bid or prior to the expiry of the bid validity period shall result in forfeiture of the **2% Bid Security (under Clause 5 of the bid document)**.
- xvi. In case, the successful bidder fails to execute the work/supply order as per terms and conditions laid down in the bid document/contract (other than delay) or items supplied are found to be lower in quality, the Purchaser shall have the right to cancel the contract at any time and may **forfeit 2% Performance Guarantee (under Clause 6 of the bid document)**.
- xvii. There shall be no part payment. The payment will only be made at the successful completion of the contract made by the contractor.

- xix. The Purchaser reserves all rights to accept or reject any bid/ proposal submitted in response to the Advertisement prior to acceptance, reasons will be communicated to the bidder on request as per Rule 33 of PPRA Rules.

#### **4. Bid Validity Period:-**

Bid validity period shall be effective for 140 days from the date of opening of financial bids. **During this period the purchaser may order for the said items as per bid.**

#### **5. Bid Security:**

Financial bid shall be accompanied by **2% Bid Security** of the total bid amount in the shape of Bank Draft/ Call Deposit/ Banker Cheque in favor of D.D.O, Federal Shariat Court of Pakistan, which is refundable on request, to the unsuccessful

bidder (s) within **two weeks** of the finalization of tender process. Bid security of successful bidders will be returned on their request, after signing of the contract and furnishing of 2% of Contract amount as Performance Guarantee. The bidders shall submit the scanned soft copy of Bid Security through EPADS and submit the original to the **Assistant Registrar (Procurement), Federal Shariat Court of Pakistan, Islamabad in a sealed envelope along with original Affidavit.**

## **6. Performance Guarantee.**

- i. The successful bidder shall deposit **2% of Contract amount as "Performance Guarantee"** in shape of Bank Draft/ Call deposit/Banker Cheque in favor of D.D.O Federal Shariat Court of Pakistan, before signing of the contract. Performance guarantee shall be retained by the Purchaser till completion of warranty/contract period **or bid validity period.**
- ii. The purchaser shall have the right to forfeit the "Performance Guarantee", if the contractor violates any of the terms and conditions of the bid document/ contract, except delay in provision of the Tender items for which liquidated damages **under clause 7 of the bid document** will be imposed.

## **7. Liquidated Damages**

If the Contractor fails in timely supply of the required tender items as per delivery schedule, the Purchaser without prejudice to any other right of action/remedy, shall deduct a **sum of money @ 01% of the total contract Price as liquidated damages**, for every day of delay from the scheduled delivery date(s) to the actual delivery date(s), provided that the amount **so deducted shall not exceed, the aggregate 10% of the Contact Price.**

## **8. Warranty**

The successful bidder shall submit "**one year Warranty Certificate**" regarding the durability of the supplied Tender items. The warranty period shall start from the date of delivery of the item(s).

## **9. Evaluation Criteria:**

There will be two types of evaluation i.e.

- (A) Technical Proposal Evaluation
- (B) Financial Proposal Evaluation.

### **A. Technical Proposal Evaluation.**

- i. The bidder(s) shall provide NTN and STRN Certificates issued from FBR with their bids, as proof of Active Tax Payer.

- ii. The bidder(s) are required to furnish an affidavit as per **Annexure-I** along-with their Technical Proposal to the effect that the bidder(s) has not been blacklisted by any Provincial or Federal Government Department, Agency, Organization or Autonomous Body or Private Sector Organization anywhere in Pakistan and they have not been involved in any litigation with any client during the last three years.
- iii. The bidder(s) are required to furnish Technical Proposal Submission Forms as per **Annexure-II** along with their Technical Proposals.
- iv. The bidder(s) shall provide documentary proof that they have their operational office within the limit of Pakistan.
- v. The bidder(s) shall provide their complete profile giving all necessary details with certificate showing minimum **01 year** relevant experience.
- vi. The samples provided by bidder(s) as per Clause-3 (VI), shall be evaluated according to the approved sample(s). Therefore, respective bidders are required to submit all necessary samples with bidder name along with their Technical Proposals.
- vii. **Bidders must specify the items for which they are submitting bids. Additionally, they should clearly indicate the models (if applicable) of the items in their Technical Proposal to facilitate a merit-based evaluation.**
- viii. The details of the bid security must be included in the Technical Proposal without disclosing the amount, to confirm its submission.
- ix. **The bidder(s) shall provide a valid Authorized Partner/Reseller Certificate, which must be online verifiable.**

#### **B. Financial Proposal Evaluation**

- i. The bidder(s) are required to furnish Financial Proposal Submission Form (Part of Financial Bid) as per **Annexure-III** along with their Financial Proposals. The Financial Proposal shall be accompanied by **2% Bid Security of the total bid price as mentioned in Clause-5 of the bid document.**
- ii. The bidder(s) are required to furnish Price Schedule/Financial Cost Sheets as per **Annexure-IV** along with their Financial Proposals.
- iii. The quoted price shall include all duties, taxes and expenses etc. in case of any exemption of duties and taxes made by the Government in favor of the Purchaser, the contractor shall be bound to adjust the same in the Financial Proposal.
- iv. In case of discrepancy arises in between the cost/price quoted in words and in figures, the lower of the two shall be considered.
- v. The evaluation of the price of item(s), which are subject to excise duty, sales tax, income tax or any other tax or duty levied by the Government, the



- price shall be determined and considered inclusive of such duties and taxes.
- vi. The Purchaser shall not be responsible for any erroneous calculation of tax rates or any subsequent changes in rates or structure of applicable taxes. All differences arising out as above shall be fully borne by the contractor.
  - vii. It is reiterated that the bid will remain valid for 140 days from the opening of the Financial Proposals/Bids. During this period, the purchaser may place orders for items at the bid rates as per requirements.

**10. Arbitration.**

All claims and disputes arising out of or relating to this agreement shall be referred by the aggrieved party to the sole arbitrator i.e. Registrar, Federal Shariat Court of Pakistan.

**11. Cancellation of Tender**

The Competent Authority reserves all rights to cancel the Tender at any stage under Rule 33 of PPRA Rules and it may call for re-bidding in Tender under Rule 34 of PPRA Rules. Reasons for such cancellation may be communicated on request.

2. The Purchaser hereby covenants with the Contractor to pay the Contractor, the Contract price which may become payable, at the time and in the manner, inconformity with the provisions of the contract and Bid document, in consideration of supply of the Tender item(s) and complete satisfaction of the Purchaser.
3. The contractor shall supply Tender item(s) in the quantity and at the rates as quoted in the proposal submitted by the contractor and as per prescribed samples mentioned in the bid document within a period of 15 days from the date of awarding of this contract. However, for items such as computers, printers, and photocopiers, the delivery period may be 6 to 8 weeks, as these items may require to be imported from the manufacturers.
4. In case, any defect appears in Tender item(s), the same shall be fulfilled by the contractor through replacement in a short span of time.
5. The Tender item(s) shall be delivered at the Purchaser's Principal seat at Islamabad.
6. The contractor shall solely be responsible for any discrepancy or damage to the supplied Tender item(s).
7. The contractor shall submit "One Year Warranty Certificate" regarding the durability of the supplied tender item(s). The warranty period shall start from

the date of delivery of item(s).

8. Bid Security of 2% of the total bid price shall be deposited by the contractor in the shape of Bank Draft/Call Deposit/ Banker Cheque in favour of the D.D.O Federal Shariat Court of Pakistan and the same will be returned to them on their request, after signing of the contract and furnishing of 2% of Contract amount as Performance Guarantee in shape of Bank Draft/Call Deposit/Banker Cheque. The "Performance Guarantee" shall be returned after the completion of "Warranty Period".
9. The purchaser shall have a right to forfeit the "performance Guarantee", if the contractor violates any of the terms and condition of the bid document/ contract, except delay in provision of the required Tender item(s) for which **liquidated damages under Clause 7** of the Bid document shall be imposed.
